<u>RRGL application Yanzick/Brey Riddle</u> – Sent an updated scope, schedule and budget. Waiting for contract from DNRC. Funding should start after September 2017. Working on a MOU with the ditch users to pay for the match portion of grant.

<u>223 Grant – Lower Stillwater Assessment</u> – Warren has been selected as the contractor to do the assessment. He will be walking the river after high water.

<u>FY 2018 Admin/310 Grant</u> – The SCD received the grant from DNRC. The amounts are: \$3,490.00 for the Admin portion and \$1,359.26 for the 310 portion. Waiting for contract from DNRC.

Landroller Repair – Will Downs can fix the hitch on the landroller this winter.

<u>ST1601 Hamilton Water Reservation</u> – The Cove Ditch has not met yet to approve this application coming out of the Cove Ditch.
